- Nutrition, Public Health, Status of women, state nutrition - 15 Marks.
- English Language (candidate's understanding of simple and primary knowledge of the English Language; simple translation up to the level of Class X etc.) - 20 Marks
- General Knowledge - 20 marks

And Para No. 2.3 – “Syllabus for Written Examination for AWHs” of the Recruitment Notice No. 134/ICDS/MTB I, Dated: 11/07/2024, have been revised as follows:

Revised - Syllabus for Written Examination for AWHs:

- An essay of 150 words in mother tongue (Class VIII standard) in the matter of how to build public awareness on AWC Services - 15 Marks.
- Arithmetic (Class VIII standard) - 20 Marks.
- Safe Cooking Practice & Public Health & Hygiene - 15 Marks.
- English Language (candidate's understanding of simple and primary knowledge of the English Language; simple translation up to the level of Class VIII etc.) - 20 Marks
- General Knowledge - 20 marks
