
Revised - Syllabus for Written Examination for AWWs:-

- An essay of 150 words in mother tongue (Class X standard) on the matter of Mother & Child Health - 15 Marks
- Arithmetic (Class X standard) - 20 Marks
- Nutrition, Public Health, Status of Women, State Nutrition Policies, and Vaccination for the Age group of 0 to 6 years - 15 Marks
- English Language (candidate's understanding of simple and primary knowledge of the English Language; simple translation up to the level of Class X, etc.) - 20 Marks.
- General knowledge - 20 marks.

Revised - Syllabus for Written Examination for AWHs:

- An essay of 150 words in mother tongue (Class VIII standard) on the matter of how to build Public awareness on AWC Services - 15 Marks.
- Arithmetic (Class VIII standard) - 20 Marks.
- Safe Cooking Practices & public health & Hygiene - 15 Marks.
- English Language (candidate's understanding of simple and primary knowledge of the English Language: simple translation up to the level of Class VIII. Etc.) - 20 Marks
- General Knowledge - 20 marks.
